

**MINUTES OF REGULAR MEETING
OF

Meeting Convened

The Board of Education of School District No. 172, Adams County, Illinois, met in regular session on May 24, 2017, at 6:00 p.m. at Quincy Senior High School, Room D137, 3322 Maine Street, Quincy, Illinois, in said school district.

Roll Call

The meeting was called to order by President Ali, who directed the secretary to call the roll. On the call of the roll, the following members were present and answered to their names: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member was absent: Member Nichols. Whereupon the President declared a quorum was present.

Moment of Silence

The President declared a moment of silence and reflection.

Pledge of Allegiance

President Ali led the Pledge of Allegiance.

Focus on Students – Good Things Going On!

1. **QHS Real Scientists.** QHS AP science students Margot Molidor, Katie Vogler, Lorrall Kanauss, Lexi Gerdes, and Rachel Meyer thanked Board members for helping fund their science presentation at QHS New Faces this spring. The girls did a flaming coffee creamer demonstration for the Board.
2. **Good News Report.** PIO Officer Raquel Piazza reported on some of the upcoming end-of-year activities. Third grade recognition ceremonies are scheduled at K-3 schools. Madison students will celebrate with their annual carnival at Madison Park. Dewey and Adams special education students will enjoy time playing on equipment at the new Kiwanis Centennial Playground at Lincoln Park. QHS graduating seniors will participate in the second annual Senior Walk through the K-3 schools. QAVTC will hold the annual STEM camp for 6th, 7th and 8th grade students in four different sessions in June.
3. **PTA Report.** QHS Principal Danielle Arnold reported that the QHS PTA has funded over \$16,000 in teacher grants at QHS.

Questions and Comments

President Ali opened the meeting to questions and comments to members of the Board, by members of the public and employees of the district, in compliance with state statutes.

Jeff Kerkhoff shared a copy of the 1918 eighth grade final exam. He also distributed information and commented on natural resources and environmental issues.

On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Reports of the Superintendent

Superintendent Webb announced that the last day of the 2016-17 school year is Thursday, June 1 for students. The last day for staff is Friday, June 2 which will start off with an end-of-the year celebration in the QJHS Morrison Theater. The 2017-18 school year begins for staff on Wednesday, August 16 and August 17 for students.

Building Committee

The Building Committee report was presented by Chairperson McNay. Updates on the new elementary schools at the Monroe, Columbus Road, Harrison Street, and 12th Street sites were presented. Eric Barnes, Klingner and Associates, paid tribute to Joel Murphy who retires next month. He said Joel led the process for the building program and was the go-to guy. He had extensive experience in building schools and played a key role in this program. He has left a lasting impact on this community.

The committee reviewed the following recommendations: Playground bids and interim phone system for Monroe site, retention reduction for Maas Construction from 10% to 5% and Flinn light pole replacement plan via NJPA Cooperative Purchasing Program.

Playground Equipment – Monroe Site

It was recommended by the Building Committee and moved by Member McNay to approve the base bid and alternate bids #1 and #4 at a total cost of \$169,460 (Doc. Reg. No. 2938). On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Interim Phone System – Monroe Site

It was recommended by the Building Committee and moved by Member McNay to approve a temporary phone system for the Monroe site from United Systems-Toshiba at a cost of approximately \$4,000. There will be further analysis before permanent systems are determined for all K-5 buildings (Doc. Reg. No. 2939). On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Retention Reduction for Maas Construction

It was recommended by the Building Committee and moved by Member McNay to approve retention reduction for Mass Construction for the Monroe site from 10% to 5%. It was noted that the retainage on this project is still more than \$600,000 (Doc. Reg. No. 2940). On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Flinn Light Pole Replacement Plan

It was moved by Member Troup and seconded by Member McNay to move forward with replacing the field lights at Flinn Stadium via the NJPA Cooperative Purchasing Program (Doc. Reg. No. 2941). On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Curriculum Committee

The Curriculum Committee report was presented by Chairperson Bailey. The committee heard a recommendation for an agreement with JWCC for a Diesel Technology Program. The District Science Leadership Team has been reviewing textbooks from several publishers over the last year. The textbooks recommended for selection are on display in Carol Frericks' office. An update was presented on the Healthy Community Investment Grant funds that will be used to provide advanced science teacher and learning activities for students in grades K-8.

Agreement with JWCC for Diesel Technology Program

It was recommended by the Curriculum Committee and moved by Member Bailey to approve the agreement with JWCC for the Diesel Technology Program (Doc. Reg. No. 2955). On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Finance Committee

Chairperson McNay presented the Finance Committee report. The committee reviewed the check register and the cash summary report. The 2016-2017 tentative amended budget was presented to the committee. Mr. Whicker reported very few changes. Information on the issuance of \$20.3M in bonds, Workers' Comp Insurance through the Prairie State Insurance Cooperative, fuel bids, and interfund loans was provided.

Check Register/Jr & Sr High Activity Fund

It was moved by Member Troup and seconded by Member Whitfield to approve the Check Register dated May 19, 2017 and the junior/senior high activity funds. On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Workers' Compensation Insurance

It was moved by Member Troup and seconded by Member McNay to approve the bid submitted by Winters Insurance Group for the Prairie State Insurance Cooperative for three years at a first-year annualized premium of \$416,426 (Doc. Reg. No. 2942). On the call of the roll, the following members voted Aye:

Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Fuel Bids

It was moved by Member Whitfield and seconded by Member Rose to approve the fuel bid submitted by Petroleum Traders Corporation, the lowest of four bids received, for a total of \$257,971.50 (Doc. Reg. No. 2943). On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Policy Committee

The Policy Committee report was presented by Chairperson Bailey. The committee continued the review of the Policy Manual with Section 4 – Operational Services. Policies 5:180 – Temporary Illness and Policy 8:25 – Advertising were laid on the table at the last Board meeting and are recommended for approval.

Adopt Policies 5:180 and 8:25

It was recommended by the Policy Committee and moved by Member Bailey that Policies 5:180 – Temporary Illness or Temporary Incapacity and 8:25 – Advertising and Distributing Materials be removed from the table and adopted. On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Discipline Committee

The Discipline Committee did not meet in May.

Resolution Providing for the Issue of General Obligation Bonds

It was moved by Member Troup and seconded by Member Ali to approve a Resolution providing for the issue of not to exceed \$23,000,000 general obligation bonds of the District for the purpose of building and equipping five new elementary schools, building an addition to the Quincy Senior High School Building, acquiring land, improving school sites, repairing existing school buildings and providing technology improvements throughout the District, providing for the levy of a direct annual tax sufficient to pay the principal and interest on the bonds, authorizing the deposit of the taxes levied to pay the bonds directly into a designated escrow account and authorizing the sale of the bonds to the purchaser thereof (Doc. Reg. No. 2944). On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Treasurer's Bond

It was moved by Member Troup and seconded by Member McNay to approve the Treasurer's Bond covering the Bond Issue (Doc. Reg. No. 2945). On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Resolution Transfer (Loan) from Working Cash to Education Fund

It was moved by Member Bailey and seconded by Member Troup to approve the Resolution directing transfer (loan) of \$2.75 million from the Working Cash Fund to the Education Fund (Doc. Reg. No. 2946). On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and

Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Resolution Transfer (Loan) from Working Cash to Operations and Maintenance

It was moved by Member Whitfield and seconded by Member Rose to approve the Resolution directing transfer (loan) of \$500,000 from the Working Cash Fund to the Operations and Maintenance Fund (Doc. Reg. No. 2947). On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Resolution Abating \$420,875 from Working Cash to Education Fund

It was moved by Member Troup and seconded by Member Bailey to approve the Resolution Abating \$420,875 from the Working Cash Fund to the Education Fund. On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

Petition for Annexation to City of Quincy and Quincy Park District

It was moved by Member Rose and seconded by Member Troup to authorize submission of Petition for Annexation to City of Quincy and the Quincy Park District for the North 12th School site (Doc. Reg. No. 2948). Whereupon the President declared the motion carried.

Name for New School at Monroe Site

It was moved by Member Ali and seconded by Member Troup to name the new school at the Monroe site Lincoln-Douglas Elementary. On the call of the roll, the following members voted Aye: Members Ali, Bailey, McNay, Rose, Troup and Whitfield; and the following member voted Nay: None; and the following member was absent: Member Nichols. Whereupon the President declared the motion carried.

President Ali thanked the naming committee for their hard work. The Board will continue to work on names for the other four new schools.
