MINUTES OF SPECIAL MEETING OF

BOARD OF EDUCATION, SCHOOL DISTRICT NO. 172 ADAMS COUNTY, ILLINOIS HELD ON JUNE 27, 2012 – 7:30 a.m.

Meeting Convened

The Board of Education of School District No. 172, Adams County, Illinois, met in special session on June 27, 2012 at 7:30 a.m. in the Board of Education Office, Room 214, located at 1416 Maine Street, Quincy, Illinois, in said school district.

Roll Call

The meeting was called to order by President Daniels, who directed the secretary to call the roll. Workers' Compensation Agreement
