

**MINUTES OF SPECIAL MEETING  
OF  
BOARD OF EDUCATION, SCHOOL DISTRICT NO. 172  
ADAMS COUNTY, ILLINOIS  
HELD ON SEPTEMBER 6, 2012 – 5:00 P.M.**

**Meeting Convened**

The Board of Education of School District No. 172, Adams County, Illinois, met in special session on September 6, 2012 at 5:00 p.m. in the Board of Education Office, Room 214, located at 1416 Maine Street, Quincy, Illinois, in said school district.

**Roll Call**

The meeting was called to order by President Daniels, who directed the secretary to call the roll. On the call of the roll, the following members were present and answered to their names: Members Daniels, Dickerson, Erwin, Mays, Niekamp, and Stone; and the following members were absent: Member Krause. Whereupon the president declared that a quorum was present.

**Questions and Comments**

President Daniels opened the meeting to questions and comments to members of the Board, by members of the public and employees of the district, in compliance with state statutes.

Mr. Richard Jones addressed the Board about the administrators who received a settlement for courses taken for superintendent certification. Additional coursework had previously been a part of the administrative compensation plan but was discontinued. He said the Board should consider these administrators for the temporary and permanent superintendent position.

Whereupon the president declared the motion carried.*

Member Krause arrived at the beginning of executive session which was duly recorded by the Board Secretary.

**Exit of Member Erwin**

Member Erwin exited the meeting during executive session at 6:25 p.m. which was duly recorded by the Board Secretary.

**Resumption of Rules**


