# MINUTES OF ADJOURNED SPECIAL MEETING OF

### **Meeting Convened**

The Board of Education of School District No. 172, Adams County, Illinois, met in adjourned special session on September 14, 2012 at 8:00 a.m. in the Board of Education Office, Room 214, located at 1416 Maine Street, Quincy, Illinois, in said school district.

### Roll Call
