

**MINUTES OF SPECIAL MEETING

**Meeting Convened**

The Board of Education of School District No. 172, Adams County, Illinois, met in special session on Monday, November 12, 2018 at 8:00 a.m. in the Board of Education Office, Room 214, located at 1416 Maine Street, Quincy, Illinois, in said school district.

**Roll Call**

The meeting was called to order by Vice-President Troup, who directed the secretary to call the roll. **Sale of Property – QAVTC Building Trades House and Lind Street Lots**

There were no bids received for the QAVTC Building Trades House at 515 S. 17<sup>th</sup> St or the three lots on Lind Street. The properties can now be sold by a realtor for no less than the minimum bid or another auction could be held.

**Dell Lease for Staff Computers**

*It was moved by Member Bailey and seconded by Member Whitfield to approve the lease with Dell Computers for 575 staff computers to be paid over three years at a total cost of \$466,934.05 (Doc. Reg. Whereupon the Vice-President declared the motion carried.

**Gas Line Connection Agreement**

*It was moved by Member Arns and seconded by Member Bailey to approve the Gas Line Connection Agreement related to the sale of the Dewey lots. The cost of \$8,686.28 to move the gas line will be split between Quincy School District and the buyer of the property (Doc. Reg. No. 3040).* On the call of the roll, the following members voted Aye: Members Arns, Bailey, Troup, and Whitfield; and the following member voted Nay: None; and the following members were absent; Members Ali, McNay and Nichols. Whereupon the Vice-President declared the motion carried.
