Entrance Fee and Requirements: Enter up to 3 works for \$12; all mediums accepted. Artworks must be original and not exceed 6 feet in any direction.

Presentation and Content: Artworks must be ready for exhibition. Wall-hung pieces require secure wire hanging devices; avoid sawtooth or plate hangers. No damaged mats. Pedestals are available for 3D works. Digital presentations need their viewing devices. The Art Center reserves the right to install works in any manner deemed necessary for exhibition or security reasons. Due to the wide variety of visitors, all entries must be appropriate for viewing by all ages. The Art Center reserves the right to refuse any work that may be considered potentially offensive.
