Meeting Convened

The Board of Education of School District No. 172, Adams County, Illinois, met in regular session on May 19, 2021 at 6:00 p.m. in the Board of Education Office, Room 214, 1416 Maine Street, Quincy, Illinois, in said school district.

Roll Call

The meeting was called to order by President Ali, who directed the secretary to call the roll. On the call of the roll, the following members were present and answered to their names: Members Ali, Arns, McNay, Nichols, Petty, and Whitfield; and the following member was absent: None. Whereupon the President declared a quorum was present.

Moment of Silence

President Ali declared a moment of silence and reflection.

Pledge of Allegiance

The Pledge of Allegiance was led by Member Petty.

Questions and Comments

President Ali opened the meeting to questions and comments of members of the Board, by members of the public. A family that is considering switching from parochial to public asked about expectations for the fall semester for the junior high. Mr. Webb stated that plans are for kindergarten through eighth grade will be in attendance every day and he is hopeful for a more traditional, back to normal environment, but ultimately, we must follow guidelines from the State.

Reports of the Superintendent

Last Day of School/End of Year Celebration Video. Thursday, June 3 is the last day of attendance for students and Friday, June 4 will be the last day for teachers. We will be celebrating staff with an end of year video highlighting events from each building during the past year and honoring each retiree. A link to the video will be provided on June 4.

Thomas Lane Award. The Thomas Lane Award for Support Persons of the Year was given to all our nurses, Director Brandy Kirby, and secretary Mary Tipton. They have been the heroes of the district for the past school year and helped us keep in-person learning all school year.

Dr. George C. Meyer Award. The Dr. George C. Meyer Teacher of Year for Education Excellence was awarded to Ching-Fen Bigelow (QJHS Math) and Sharla Heightman (QHS Math).

School Based Health Care. Carol Nichols will be replacing Mike Troup as Chairperson for the School Based Health Care Committee.

Finance Committee

Chairperson McNay presented the Finance Committee meeting report. The committee reviewed the monthly financial update, cash flow summary, and check registers. The district is 83% through the fiscal year and the Education Fund expenditures were 74% through April 2021, several other funds are below what was originally budgeted. The district received a sole fuel bid from Energy Petroleum Company for an escalating bid price of \$348,775.50. Escalating price has worked well the past few years and it has realized the savings. Meetings going forward have been shifted from 7:30 a.m. to noon, starting with the meeting slated for June 21.

Human Relations Committee

Chairperson Nichols reported on the Human Relations Committee meeting. Superintendent Webb spoke about the Diversity and Inclusion Committee. Board Member Carol Nichols spoke about the upcoming Healing Conversations in Quincy webinar (NAACP with United Way). The committee also sent out "Safe Place" window clings to all QPS buildings. Human Resource Secretary Dickens spoke on the distribution of service pins for all QPS employees. Pins are distributed in the fall to new hires, as well as employees who completed years of service in increments of five years. Director of Personnel Lisa Otten added QPS honors an employee's service with a plaque upon retirement. Director of Personnel Otten also spoke about the Welcome Bags that will be distributed to all new certified staff starting in the 2021-22 school year. (35-50 approximately \$100 per bag) and plans are to reach out to GREDF for additional items. All early hires have been placed for the 2021-2022 school year per Director of Personnel Lisa Otten.
