Meeting Convened

The Board of Education of School District No. 172, Adams County, Illinois, met in special session on May 26, 2011 at 7:30 a.m. in the Board of Education Office Room 214 located at 1416 Maine Street, Quincy, Illinois, in said school district.

Roll Call

The meeting was called to order by President Daniels, who directed the secretary to call the roll. 2010-2011  
Tentative Amended  
Budget

Business Manager Bud Martin presented the Tentative Amended Budget for 2010-2011. He explained that revenues in the Education Fund were \$49.8 million, up from \$47.3 million and expenditures were \$49.5 up from \$47.4 million. The difference is a gain of \$436,374 in the Education Fund. Mr. Martin said amending the budget will alleviate a recurring finding on the financial audit.

It was moved by Member Mays and seconded by Member Dickerson to approve the 2010-2011 Tentative Amended Budget and set the hearing date for June 30, 2011 at 7:30 a.m. at the Board of Education Office (Doc. Reg. No. 2534). On the call of the roll, the following members voted Aye: Members Daniels, Dickerson, Krause, Mays, and Stone; and the following members voted Nay: None; and the following members were absent: Members Erwin and Niekamp. Whereupon the president declared the motion carried.

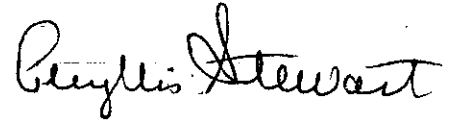
