

**MINUTES OF SPECIAL MEETING

**Meeting Convened**

The Board of Education of School District No. 172, Adams County, Illinois, met in special session on September 11, 2012 at 5:30 p.m. in the Board of Education Office, Room 214, located at 1416 Maine Street, Quincy, Illinois, in said school district.

**Roll Call**

The meeting was called to order by President Daniels, who directed the secretary to call the roll.
