## **BOARD MEETING REVIEW FROM SUPERINTENDENT WEBB**

The District's FY 2019 audit was presented to the Finance Committee. Valerie Flynn, a partner with Zumbahlen, Eyth, Surratt, Foote and Flynn, Ltd. said that it was a good year for Quincy Public Schools. There were no findings for the year ending June 30, 2019. Chief of Business Operations Ryan Whicker and Special Education Director Eryn Beswick and their teams have done an excellent job strengthening internal controls and incorrect fund coding had been issues in the past but are no longer a problem. It is rare for a district of our size that deals with state grants, federal grants and all the moving parts to have an audit with no findings. Last year there were four findings but in 2014, when Mr. Whicker started at QPS, there were 14 findings. The district has continued to improve each year under his guidance.

The audit report showed improving balances in key operating funds. The education fund took in \$1.37 million more than it spent, finishing the year with a \$5.5 million balance. The operations and maintenance fund finished the year with a \$1.18 million balance or 2.5 months in reserve. This is quite an improvement from the \$48,510 deficit in this fund in 2017. Transportation ended the year with a \$420,417, far above the \$174,451 deficit in 2017.

The Board approved the appointment of four community members to the District Improvement Team Committee (DIT). New members are Rachael Petty, Pat Arnold, Dr. Gelinda McCarty, and Laurel Klinkenberg. The DIT Committee serves as the Board Curriculum Committee and Discipline Committee. The committee meets quarterly and hears updates from the School Improvement Teams
